Guest Cottage:

This is an incomplete building comprised of two rooms, constructed for the purpose of housing a cold-room . Gross floor area approx. 533.00 sq. ft.

Old Farm Building/Pimento House:

This is a farm building and was originally the pimento house. It is comprised of open plan space and appears to have been used recently as a chicken enclosure. **Gross floor area approx. 1,260.00 sq. ft.**

Dairy Shed:

This is a small, modern dairy building that comprises a room for machinery and milk storage, a milking parlour with six milking stations, in and out cattle-races, etc. **Gross floor area approx. 676.00 sq. ft.**

Farm Manager's Cottage/Roadside Residence:

This building is comprised of three rooms, verandah, bathroom and kitchen facilities. Gross floor area approx. 504.00 sq. ft.
